## Refund Conditions

Please be advised that once tuition fees are paid, there is no automatic entitlement to a refund. If a student wishes to withdraw from a course, they must submit a written application for a refund to the Headmaster, clearly stating the reason for their withdrawal.

If the applicant has not yet commenced their course, a refund may be granted, but an administration fee of \$2,750.00 (plus an additional charge of a Homestay Arrangement Fee for a student staying in homestay) will be deducted from the refund amount.

Please note that no refunds will be issued under the following circumstances:

- Once the course has commenced
- To any student who has been expelled from the school

In the event that an applicant experiences a change in immigration status once the course has commenced, no refund will be made after the term has commenced, even if a student's parent visa status has changed.

Students must provide their updated visa status to be considered for enrollment in the following year.

Furthermore, please be aware that fees at Rosmini College are subject to change and are periodically reviewed by the Rosmini College Boards.
