Refund Conditions

Once the tuition fees are paid there is no automatic entitlement to a refund of fees. Applications for refunds must be made in writing to the Headmaster stating why the student is withdrawing from a course.

If the applicant has **not** begun his course, fees will be refunded less the administration fees of \$2000.00(including Homestay Arrangement Fees)

If the applicant has begun his course, the following will be considered in determining any refund:

- An administration fee of \$2000.00 (Homestay Arrangement Fees)
- Tuition costs incurred by the school, including those affecting staff employed for the full vear

on the basis of enrolments

- Catholic Attendance Dues and Levy payments
- Any other costs considered relevant

No refunds will be made:

- After the end of Term 1
- To any student expelled from the school
- On the basis of a change of immigration status after 1st March.
