## Refund Conditions

Please be advised that once tuition fees are paid, there is no automatic entitlement to a refund. If a student wishes to withdraw from a course, they must submit a written application for a refund to the Headmaster, clearly stating the reason for their withdrawal.

If the applicant has not yet commenced their course, a refund may be granted, but an administration fee of \$2600.00 (plus an additional charge of a Homestay Arrangement Fee for a student staying in homestay) will be deducted from the refund amount.

Please note that no refunds will be issued under the following circumstances:

- Once the course has commenced
- To any student who has been expelled from the school

In the event that an applicant experiences a change in immigration status once the course has commenced, the following factors will be considered in determining any potential refund:

- An administration fee of \$2600.00 (plus an additional charge of a Homestay Arrangement Fee, if applicable)
- Tuition costs incurred by the school, including those related to staff employed for the entire academic year based on enrolments
- Catholic Attendance Dues and Levy payments
- Any other relevant costs deemed necessary.

Please note that the refund amount will be assessed on a case-by-case basis, taking into account the specific circumstances and costs associated with the change in immigration status. We will consider all relevant factors to determine a fair refund, considering the financial obligations and commitments of the school.

Furthermore, please be aware that fees at Rosmini College are subject to change and are periodically reviewed by the Rosmini College Boards.

For short-term stays, there is a minimum requirement of one term, and regardless of the actual duration of the stay, the student will be required to pay the full fees for one term.

In the case of a group of short-term students, an administration and homestay arrangement fees deposit is required three months prior to the course start date. Please be aware that if there is a cancellation by the agent or parents after the deposit has been made, due to circumstances related to the agent's company or personal changes in the parents' circumstances, the deposit will not be refunded.
